The Government of India (hereinafter called "Borrower") has received financing from the International Bank for Reconstruction and Development (IBRD) in the form of loan (hereinafter called "loan") towards the cost of Telangana Municipal Development Project [TMDP]. The Director of Municipal Administration, MA&UD Dept., Govt. of Telangana, an implementing agency of the Client, intends to apply a portion of the proceeds for consulting services.

The consulting services ("the Services") include the following two components:

- Update of Revenue Database
- and registry which covers total information of a property with reference to its Geospatial Information, structure, tax, registration details.

The above components are to be taken up as parallel activities as completion of one component is not contingent upon the other component. However, the planning and implementation is to be done keeping in view the project requirements as a whole and the outputs are to be integrated based on requirements.

The firm should have or ready to depute **200 No.** of field surveyors within one week of the award of the contract.

The implementation period is **3 months**.

The Client invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criteria are:

- Annual Turnover = **Rs.3.00 Cr.**

- (ii) The firm shall be in the core business of GIS Mapping during the last **five (5)** years.
- (iii) The firm shall have successfully completed at least **2 similar** assignments in any Govt./ULB in the area of GIS mapping during the last **5 years**.
- (iv) NRSC empanelled firms in GIS Mapping will be preferred/desirable.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers*, January 2011 revised July 2014 (Consultant Guidelines), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. In case any firm wishes to associate with another firm, it should inform in their Expression of Interest about the nature of association whether as joint venture or as sub-consultant.

A Consultant will be selected in accordance with the Selection Based on Consultant Qualification (CQS) method set out in the World Bank's guidelines selection and employment of consultants by World Bank borrowers, January 2011 revised July 2014.

One firm may get maximum **3 packages** based on their eligibility and capacity. The details of the packages are enclosed in the Terms of Reference.
